9.	<p><b>Leicestershire Agreed Syllabus</b></p> <p>Beth Clements – looking at if any grants from LCC. In normal times the LA contribution is to provide a room and refreshments.</p> <p>TN said that it is a statutory requirement of the LA to provide the funding for the Syllabus. This is going to cost £17,000.00. Leicestershire SACRE have been entrepreneurial in the past so we have £9,000 to put towards this figure.</p> <p>The syllabus will need a launch, SACRE could raise funds for this but LA will need to help.</p> <p>The licence runs out in August 2021. This is for Modal A which is now updated and there is a Modal B as well. Fiona Moss, RE Today is willing to do a virtual launch if still under restrictions.</p> <p>Meeting with RE Today and Fiona Moss and practitioners to discuss the Syllabus. The cost is now at £50.00 per school plus VAT, assuming we have 300 plus schools</p> <p>JC felt this was quite expensive. There are alternative providers.</p> <p>YM-M said happy to look at other providers. This new Syllabus needs to be in place by September and the licence expires in August so pressed for time.</p> <p>If the Syllabus was to wholly change this would have an impact on the practitioners.</p> <p>The Syllabus Modal A not changed but been updated. Model B looks quite</p>	

	<p>different, aims to help children to have a greater understanding all beliefs. AH questioned if teachers would go to another launch if it was the same and if it is very different no capacity to change all lessons.</p> <p>TN said there is need to make a decision.</p> <p>JC suggested extending the licence for another year. This was done last time but this was when SACRE wrote their own Syllabus.</p> <p>TN said they would ask REToday.</p> <p>BR suggested TN to write to Jane Moore and gently put it to her that she has to provide the funds to produce this, and add Mr Rhodes name in there.</p> <p>BC said once SACRE know what they want and how much, put the application to the LEEP Board, TN will do this and send to Beth and she will get into the right work stream.</p>	TN copies to BR, YM-M, RC
