### Provider Portal single sign on

Leicestershire County Council improved the login process for the Provider Portal making it easier for you to reset your password. Registered provider portal users have been sent instructions on how to sign up for this process over the past few months. Thank you to all users that are using the single sign on login process. If you have not yet registered for the single sign on, we will reissue the instructions on how to do this via email by 29<sup>th</sup> November 2024.

The option to call or email Leicestershire County Council to reset your passwords will no longer be available from 01<sup>st</sup> January 2025, so it is important that you complete the registration process before this date.

The process for requesting new access to the Portal remains the same; the manager can complete the Provider Portal access request form online.

From the 18<sup>th</sup> November 2024 the home care await care list will be emailed to framework providers by the brokerage team at slightly different times. The times will now be 9AM, 12PM and 3PM.

- the eligibility criteria for being able to make claims through the scheme
- how the funding can be used, including the training courses and qualifications within the scope of the scheme
- details on how to access the fund to make a claim, including a demonstration of the new online claims service.

## LLR online vaccination hub launches to support local people

The Leicester, Leicestershire and Rutland Integrated Care Board have launched an online vaccination hub which has been developed to help local people find out about all the free NHS vaccinations they are eligible for. It also provides up to date information about the importance of vaccinations and importantly how to get vaccinated in LLR.

The first of its kind online hub, is a dedicated resource to provide people in LLR with all the information they need about seasonal, and NHS-recommended vaccinations for all stages of life beginning with pre-pregnancy, up to older adults. There is also tailored vaccination information for people with specialist healthcare needs.

With the introduction of new vaccines such as RSV and a rise in whooping cough and measles cases over the last 12 months it is vital that our communities can access information to help protect themselves or anyone in their care. The online vaccine hub provides all the information people need in a format that is easy to access and navigate.

#### **Mouth Cancer Action Month**

November is Mouth Cancer Action Month. The message is- 'if in doubt, get checked out'. Over the next few weeks, the Oral Health Improvement Team will be sharing information about the signs of mouth cancer, how to reduce the risk, and what to do if you notice anything concerning.

It is important for everyone to be mouth aware and look out for any changes, including:

- Non healing ulcers (lasting more than 3 weeks)
- Red and white patches
- Unusual lumps or swellings

If you notice anything out of the ordinary, make an appointment to see your dentist or GP. This video shows you how to check your mouth at home.

# Have your say on the refreshed Leicester, Leicestershire and Rutland (LLR) draft Suicide Prevention Strategy, 2024-2029.

Leicester City, Leicestershire and Rutland Councils have refreshed the LLR Suicide Prevention Strategy for 2024 – 2029. Suicide is not inevitable; it can be preventable. The strategy describes how organisations (such as councils, the police and NHS) plan to work together across LLR to prevent suicide over the next 5 years.

We want to hear your views on the draft Suicide Prevention Strategy for LLR. Your views will be used to inform the final version of the strategy, and the corresponding action plan which will detail how the priorities will be achieved.

The consultation is open to everyone in Leicester City, Leicestershire and Rutland.

The consultation is now live and will run until midnight on 22 December.

### Transport help for Covid-19 and flu vaccinations

To help people that are unable to travel to a vaccination clinic a free transport service is now available.

The service has been set up to provide eligible residents in Leicestershire and Rutland the opportunity to get vaccinated this autumn by helping them to get to and from a vaccination clinic if they live remotely or have no other means of transportation.

To check your eligibility please call: 01530 512456. Telephone lines are open Monday to Friday until midday

The service is operational to provide transport Monday – Friday all day.

Please note the service provider will check your eligibility and will book you into a suitable Covid-19 and flu clinic. The service will arrange for people to be taken to and from their appointment, all at no cost.
