Guidance and good practice

Increase in the outbreaks of Scabies - reporting guidance

Outbreaks of scabies are most likely to occur where people live in close proximity, and in settings where individuals receive personal or health care or staff working in these settings. The elderly, young (children and young adults) and immunocompromised are particularly vulnerable to scabies. Those residing in settings such as care homes and prisons are especially susceptible to outbreaks.

An outbreak is defined as 2 or more epidemiologically linked cases of scabies within an 8-week period. This can include staff members. If an outbreak is suspected care homes should contact the UK Health Security Agency (UKHSA); Tel. 0344 2254524, option 1. (Contactable 24/7), for information and guidance on the management and treatment. There is a link below to the latest Government guidelines.

Storage of Controlled Drugs

The Controlled Drugs Liaison Officer has issued the following guidance around the safe storage of controlled drugs (CD) within care homes.

- 1. All CD cabinets must not have any text/images on the front of them to indicate that controlled drugs are stored inside.
- 2. All CD cabinet keys to be kept separate and on their own from other keys
- 3. Nothing except controlled drugs to be stored inside the CD cabinet (the CD registers are exempt from this if there is room).
- 4. Expired CD's that are set to be destroyed to be kept in their original packaging until they are to be destroyed in one sitting. The denaturing kit MUST be kept INSIDE the CD cabinet once it has CD's inside if with water added to start and complete the denaturing process.
- 5. Once 24 hours has passed, after the CD's have been denatured, they must be disposed of via the clinical waste/pharmacy collection.

Additional Funding for Whzan Blue Boxes

You may recall that Tara Marshall attended the Provider Forum in May 2024 to talk about the benefits of implementing the Whzan Blue Box in Leicestershire care homes. The roll-out was put on hold over the summer whilst funding was obtained for a wider roll-out but I'm pleased to inform you that funding has now been released to provide an additional 40 Whzan Blue Boxes as part of the Connected Care Programme and the Whzan Blue Box is being rolled out to residential and supported living homes across Leicester, Leicestershire, and Rutland, with funding secured until 2028.

This innovative equipment empowers care homes to better monitor residents' well-being by detecting early signs of deterioration. It records vital observations, weight, and secure photographs, and integrates seamlessly with GP systems and most digital care records, eliminating the need for duplicate data entry. The Whzan Blue Box has been proven to reduce hospital admissions through early intervention, enabling residents to remain in their preferred care setting for as long as possible.

Message in a Bottle

The Lions Club's "Message in a Bottle" program is designed to assist emergency responders in providing timely and accurate medical treatment to individuals who are unable to communicate critical medical information in the event of an emergency. The program involves placing a standardised form containing essential medical details inside a plastic bottle, which is then stored in the person's fridge. A sticker is placed on the fridge to alert emergency workers to its presence.

The standardised form typically includes details such as medical conditions, allergies, current medications, emergency contacts, and a brief medical history. This information can be vital for emergency responders to provide appropriate and timely care. Many people are also using the bottle to keep DNR information close at hand.
