#### **Guidance and good practice**

#### Fraud Awareness - Care Providers

<u>Social care fraud</u> is fraud perpetrated against councils and other public bodies, which involves people dishonestly obtaining social care funding that they are not entitled to. This can be direct or indirect and anyone can commit social care fraud.

Fraud is estimated to cost the public sector £40 billion annually Loss to local government is estimated to be £7.8 billion Adult social care is a high-risk area of fraud due to the fact it is means tested and is a high spend area for local authorities.

#### Reporting fraud

If your concern is in relation to:

- Council Tax fraud please contact the relevant Council Tax authority, e.g. district council or unitary authority.
- Benefit fraud (e.g. Housing Benefit, Universal Credit) please contact National Benefit Fraud
- Undeclared earnings please contact HM Revenue & Customs
- Energy theft please contact Stay Energy Safe

## **Emergency Alert Test – 7 September**

The UK government is testing the Emergency Alerts system on **Sunday 7 September 2025 at 3pm.** Compatible mobile phones and tablets will receive an alert, make a loud siren-like sound and vibrate. You will not need to take any action.

The Emergency Alerts system is used to warn if there's a danger to life nearby, including extreme weather. Regular testing ensures the system is functioning correctly, should it need to be used in a life-threatening emergency.

There are Government assets that you may find useful, including an <u>Easy Read PDF</u> <u>explainer</u>, <u>copy for vulnerable adults</u>, and <u>posters of various sizes</u> you may wish to display in your setting.

#### **Whzan and Consent**

For care homes using the Whzan / Connected Care technology, you should ensure that consent is gained from each person, or that there is a MCA / best interest decision in place, for the ongoing monitoring required for the tool.

Please note that whilst this may appear to differ from the position of other local authorities promoting the technology, Leicestershire County Council's position reflects the law

#### Caring for those with CPE/CRO - Webinar

Regional NHSE are reporting that across the East Midlands care home and domiciliary care providers are refusing to accept individuals with Carbapenemase Producing Enterobacteriaceae (CPE) also known as CRO. In most cases these individuals are colonised with the organism and standard infection prevention precautions are suffice after a risk assessment.
