LLR Care Record: Tackling Winter Pressures

The Leicester, Leicestershire and Rutland (LLR) Care Record joins up the dots between people's health and social care records and could prove vital in helping the NHS and councils manage winter pressures this year.

The LLR Care Record joins up people's health and care records across the NHS and local authorities. It means information recorded about someone's health and care such as illnesses, medications and hospital admissions can be accessed by different people who are directly involved in their care. Hospitals, GPs and other health and care workers have always tended to have separate records - the LLR Care Record allows the data from these to be seen in one place.

Evidence has shown that the LLR Care Record proved particularly useful in helping colleagues discharge patients from hospital, knowing that the right support was

available via social care services. As more data is being added in all the time, the usefulness of accessing the LLR Care Record will only grow.

More than 21,000 staff in LLR health and care providers and East Midlands Ambulance Service have access to the LLR Care Record for direct patient care. It has been rolled out across adult social care in Leicester City Council, Leicestershire County Council and Rutland County Council, and rollout is progressing in Leicestershire Partnership Trust, University Hospitals of Leicester, Patient Care Locally CIC, GP practices, LOROS and Rainbow hospices, and community pharmacies, with further organisations joining soon.

NHS and social care staff are encouraged to incorporate the LLR Care Record into their working lives. Refresher training is available for individuals or teams.

We are also hosting our 'What is Adult Safeguarding?' Information Session on **Thursday 20th November at 10am**. Bookings can be made <u>via Eventbrite</u>. Please note this session is for community and voluntary sectors in Leicester, Leicestershire and Rutland only. It will cover topics such as:

- what is adult safeguarding ,
- understanding the categories of abuse,
- how you can identify signs of abuse and
- what to do if you are worried about someone you know or support.

This is achieved through our facilitators talking through a PowerPoint presentation and completing small group exercises with participants. The events last approximately 45 minutes with 15 minutes for questions at the end.

Local resources

For Adult Safeguarding Week we also have an article published in the East Midlands Safeguarding Adults Board (EMSAB) Network newsletter on good practice examples and case studies which will be circulated across our networks during the week.

We are launching a new "MCA What Good Looks Like" resource on the topic of Coercion and Domestic Abuse. This is a short practice guide is to support practitioners alongside our existing "MCA What Good Looks Like" series which can be found on our procedures website.

Finally, we will be <u>publishing our local resource pack</u> (updated annually) promoting the "See Something Say Something" campaign on the theme of prevention and domestic abuse in older people.

LLR Appliance Prescription Service launch November 10th 2025

From 10th November, a new centralised service called the LLR Appliance Prescription Service (APS) will be managing prescriptions for bladder and bowel appliances instead of some GP practices around the County.

Examples of appliances included catheters (long-term and intermittent catheters), sheaths, leg and night bags and associated ancillary products. However, please note that the Service does not include stoma appliances, incontinence pads or medicines.

Existing prescription ordering arrangements for bladder and bowel appliances should be followed up to and including Sunday 9th November.

What this will mean for Care Home Staff and Residents

Participating GP practices have already registered patients who are currently prescribed bladder and bowel continence appliances with the LLR Appliance Prescription Service.

In the forthcoming week, patients can expect to receive information by email or post about the changes.

From Monday 10th November 2025 onwards, the Appliance Prescription Service will call your care home regarding these patients to introduce the service, answer any questions, and confirm which appliances are needed by residents who use them. The service will continue to contact your home each month to repeat this process, ensuring residents receive their appliances promptly and any issues are identified early.

New patients will be referred into the LLR Appliance Prescription Service by either the GP, secondary care at discharge or following an outpatient appointment or by the District Nursing Team.

Adult Social Care Survey 2025/26

In January 2026, a postal survey will be sent to approximately 1,800 people receiving services commissioned by Leicestershire County Council, to ask them about their quality of life, the impact that our services have on their quality of life, and their general health and well-being.

This is a statutory annual survey undertaken by all local authorities on behalf of the Department of Health and Social Care. Analysis of the survey is used to inform and support policy and decision making at both the local and national level, and to improve care, services, and outcomes for local populations.

The survey is sent to a sample of people who received a long-term service on a given date, and includes those living in the community e.g., recipients of home care,

day care, or direct payments as well as service users in permanent residential or nursing care placements.

For care homes, some additional checks will be completed in December to check whether your residents have capacity to complete the survey. If you advise that they haven't got capacity, then they can be excluded. Only a random sample of residents will be chosen in the survey, so only some care homes will receive this letter checking capacity.

How can you help?

- If you receive the letter checking capacity in December, please return this in the pre-paid envelope to County Hall
- If you have residents who receive the survey in January, please give them the
 opportunity to complete this survey, and again return the paperwork in the
 pre-paid envelope to County Hall

People's views are important, so we want to ensure we can get as many as possible to respond to the survey. Results are anonymous, however if somebody indicates that they feel unsafe then confidentiality can be breached to identify them and follow up any serious concerns.
