Changes to 2 year old funding checks

You will all now be aware that parents can now complete their own checks by visiting www.leicestershire.gov.uk/appy-for-2s. Parents can then set themselves up with a Citizens account – something they will need to do in readiness for applying for their child's school place. Once they have completed a check they will get instant confirmation of their eligibility via the Citizens portal. Parents should then bring a printed copy of this confirmation – including the reference number, to you so that you can support the parent in completing the PSOU, ensuring you add the CURN number to it so that you can claim easily for the funding at the headcount point.

Please note that parents are no longer receiving confirmation letters from the local authority or accompanying PSOUs and this is something they should complete with you.

If a parent has not printed out their confirmation – assuming you have the facilities, they could log into their account and show you the confirmation details.

30 hours funding update

Firstly a huge thank you to all of Leicestershire's providers who have been so supportive and positive through what has, at times, been a frustrating checking / validation process. That said, as we come to process the headcount data, together we have ensured access to funded places for more than 4000 of Leicestershire's parents – which is a great achievement!

Below are a few important points to remember as we move forward:

- Now you have submitted to the local authority all your initial DERN numbers for the autumn term, you
 will be able to go ahead and revalidate those same codes as parents are asked to re-check their
 eligibility.
- You can revalidate / check DERN numbers through the provider portal. Please remember that if it is the
 first time you are entering a DERN number (even if it has been validated by the local authority
 previously), you will need to treat this as a new code / entry.
- Parents should be aware of the 'end date' of their eligibility this is included in their confirmation notification they get in their government gateway account.
- Parents should ensure they re-check their eligibility before their end date expires to ensure continuity of funding.
- Once they have re-checked, as with the 2 year old funding confirmations, they can either bring you a
 print out of their confirmed re-check, or if you have the facilities, log into their government gateway
 account and show you the confirmation.
- If a parent does not re-check their eligibility by the end date or when re-checking is no longer considered eligible for the funding they will enter their grace period. This has been communicated to you via the confirmation emails the local authority have been sending. The grace period end date is the point to which you can continue to offer the funded sessions unless a parent providers you with further evidence of their eligibility.
- Finally please remember that parents can take up the extended entitlement the term after they are issued with a DERN number, assuming they meet the eligibility criteria for the funding according to their child's date of birth which is the term after their 3rd birthday.

External Training / Qualifications

Doncaster College and University Centre are offering a BA Top Up in Early Childhood Studies (<u>Distance</u> Learning) which is completely on line study supported by personal tutor, materials and assignment support.

SEND: Writing Person Centred Outcomes and Creating One Page Profiles

Safeguarding and Radicalisation

The Department for Education has recently published an updated <u>Safeguarding and Radicalisation Research</u> report.

The radicalisation of children and young people is an area of growing concern within the UK. Yet the issue is complicated, not least because individuals who become radicalised do not follow a single pathway. This research aims to look at, and understand at a deeper level, the approaches being used to support children and families who are at risk of radicalisation.

Child Protection Thresholds

The NCB have reported that the thresholds for a child qualifying as <u>'a Child in Need'</u> had risen considerably in the last three years.

Internet Users are using Peppa Pig to target children

Parents and carers need to be extra vigilant when allowing children to watch videos via the internet. The Virtual College has published an article highlighting that children are placed at significant risk of being exposed to harmful material through a simple <u>Peppa Pig</u> google search.

Local News

Early Years Pupil Premium (EYPP)

Too few children in Leicestershire are accessing EYPP. Only 4% of 3 year olds benefitting from some funded early education in Leicestershire claimed EYPP compared to 11% nationally. 326 three year olds were recorded as eligible and claiming EYPP (January 2017 data).

In Leicestershire, responsibility for making applications for EYPP rests with parents. This can make it challenging for providers to identify eligible children. We have created some <u>suggestions to help providers promote the EYPP</u> to parents in ways that will increase take up.

Support for Children with Disabilities Framework Re-opening

The framework to provide services to support disabled children and young people is to be re-opened to allow new organisations to tender in November 2017.

Short breaks and domiciliary care for Leicestershire disabled children and young people are being provided through a framework that started on 1 April 2017 and are aimed at providing support to prevent family breakdown, allowing the children and young people to remain in the family home.

This framework has an initial period of two years with options to extend for a period, or periods, of up to two further years in total. It includes an annual "refresh" that allows additional providers to tender for inclusion on the framework.

Leicestershire County Council is re-opening this framework for the first time and will be refreshing the following Lots:

- Lot 1 Short Breaks allows disabled children and young people to spend time away from their parents/carers for positive opportunities and activities.
- Lot 2 Domiciliary Care provision of support and care in the child's/young person's own home.

The timescales for this framework re-opening are:

Invitation to Tender published - November 2017 Closing date for tenders - December 2017 Award notification - February 2018 Effective date - April 2018

Successful tenderers will be appointed to the Framework for the remainder of its term, joining current service providers in being available to the Council to call-off from.

Schools and settings are being asked to trial these new documents in the Autumn term, provide feedback and then they will be reviewed and finalised in the Spring term.

DAF payment

If you have any children who are eligible to claim the DAF payment, please can you upload a copy of the PSOU that nominates your setting to receive the funding along with evidence they receive DLA via AnyComms **no later than a week after the close of headcount** (for the autumn term this means sending this information by the 9th October 2017).

Any information sent in after this date means that the DAF payment will not be paid until after the following terms head count.

Please also be aware that DAF payment is made on an annual basis from the first point at which you receive funding.

If the child moves setting during the year the DAF funding will not move with the child.

The local authority will continue to pay the DAF to designated provider as long as they are claimed for via the headcount process.
