## Funding

### Summer Final Payment

You will have received your final payment breakdown for the summer term. Please ensure that you check this is correct and if not please amend the adjustment task accordingly.

### Summer adjustment task live

You can now make adjustments to the Headcount. This will be open until 5pm on Wednesday 12<sup>th</sup> June.

### School Leavers

Please remember to add an end date to all children who will be leaving your setting for school. To ensure you have a sustainable cashflow, you will receive 100% initial payment for all children remaining in your setting.

You will need to consider the amount of leavers in the summer period and the starters for the autumn period. If you have 20 leaving in July, but 20 starting in September roughly doing the same hours, you may not wish to add an end date at this stage, so that you can remain sustainable at the beginning of the autumn.

### Autumn period validation

Please remind new parents that they must apply with the HMRC by the 31<sup>st</sup> August to be eligible for 30 hours in the autumn period. We would recommend them applying by end of July.

There continues to be a relatively high number of codes that have not been re-validated and have passed their grace period. Although we know this is the parent's responsibility you can use the expiration dashboard to keep you up to date with the current situation.

### Writing effective progress summaries

The EYFS requires practitioners to review children's progress and share a summary with parents at two key points, between the ages of 24 and 36 months and at the end of the Early Years Foundation Stage (EYFS) in the EYFS profile.

Beyond this, the progress summary is a valuable document which celebrates children's development; offers parents an opportunity to further discuss with practitioners and other professionals; and provides practitioners with an opportunity to reflect on success, next steps and future goals.

An effective progress summary will share accurate levels of development, will be informed by holistic knowledge of the child both at the setting and at home, and will reflect a practitioner who is highly attuned to the child.

Progress from the Start is a programme designed by Leicestershire County Council which will support you in tracking children's progress and planning for their development in the EYFS.

## Children in Care

Those of you who have Children in Care in your setting will be familiar with the PeP process and will have attended a PeP meeting facilitated by either Jill Thompson or Helen Moses.
