## **COVID-19 vaccination data for the capacity tracker**

It is critical to monitoring the take up of the vaccination, including how best to support providers and staff to access the vaccine, that your organisation completes the vaccination take up information requested on the national capacity tracker regularly. Completion of the tracker is a requirement of receipt of the Infection Control Fund monies. ## **Care home testing update: Lateral Flow Device (LFDs) approval for self-test granted**

The Department of Health and Social Care have announced an update on staff testing using Lateral Flow Device (LFD) tests. Care home staff are now able to take and register their twice weekly LFD tests at home, before they arrive at the care home to start work.

This only applies to care homes.

## **Business Continuity Plans**

Providers are asked to review their business continuity plan to ensure areas such as extreme staff shortages are covered. We have found some providers have had loss of more than 50% of their staff due to isolation or testing positive for COVID-19 which can have a significant impact on service delivery. ## **Statement on working during isolation period**

A Statement jointly issued by the Department of Health and Social Care, Public Health England, Care Quality Commission (CQC) and the Association of Directors of Public Health on the 26<sup>th</sup> January 2021 has stated that under no circumstances should staff who have tested positive for Covid-19, regardless of whether they are

displaying symptoms or not, work in a care setting until the legally required period of self-isolation has ended. The [national guidance](#) is clear on this.

Where the CQC has concerns, it will take swift regulatory action.

This is to ensure the health and social care system works in the best interests of all.

Staff who are off sick or are self-isolating should continue to be paid their full wages. Employers are able to access funding for this purpose from the Infection Control Fund.

## **Rapid Testing Fund**

In Bulletin 70, we highlighted the Government's Rapid Testing Fund that has been set up to support Lateral Flow Device Testing in care homes.

Leicestershire received £1.6m of the £149m national Rapid Testing Fund. The 80% payment to care homes has been initiated and your payment should be in your bank account by Wednesday 3 February. The sum paid to you is equivalent to £263 per bed.

Further information will follow about use of the 20% discretionary part of the fund, the grant conditions and the monthly reporting required. Full details of the Rapid Testing Fund, including the grant conditions, can be found on the [DHSC website](#).
