We advise you to process your task as early as possible to avoid any technical difficulties you may have. Please note any children/increases to hours missed off both the headcount and amendment tasks will not be backdated.

Please note that if the child is a school leaver in Summer 2022 and stretches their funding across the academic year, they are still entitled to their full allocation. This figure has been amended and they can stretch their funding over 51 weeks e.g. 1140 / 51 weeks = 22.35 hours per week. If you have stretched over 50 weeks, or less, you will need to amend your figures during the Spring/Summer Periods to include the final week in August.

If you have received an initial payment, you must also complete the headcount/amendment tasks for that period, otherwise this will be reclaimed from your future payments.
