Dear Colleagues

Please find below several articles which will hopefully be useful to you and your teams. In particular there are webinars taking place later this week to answer staff queries relating to the COVID-19 vaccine.

## **New Leicestershire social care enquiry and bookings phone line**

In the last two bulletins we have shared the new Leicestershire vaccination web page, including enquiry form, and email address, set up specifically to answer social care provider and worker queries about COVID-19 vaccination.

We now have a dedicated phone line to answer questions and make vaccination appointments. Where workers have their own email address, it is still easier and more convenient for them to book for themselves using the appointments link – however we recognise that a phone line is essential where people don't have an email address or are unable to access the internet.

## **COVID-19 vaccination now available at the Loughborough hospital hub**

Please let eligible staff based in this area of Leicestershire who have not had their first vaccine dose know that this hub is now in operation.

## **Webinars to answer staff questions**

### *Thursday 11 February: BAME vaccine seminar*

### *Friday 12 & 19 February: Drop-in vaccine seminar for frontline social care staff*

Following the success of its first webinar last week, East Midlands ADASS are running two more virtual 'drop-in' sessions on Friday 12 and Friday 19 February between 14.00-15.00 to answer questions about the vaccine.

Staff do not have to register – they can simply use the link below. Please encourage your workers to dial in.

Are you worried or concerned about having your COVID-19 vaccination? Are there questions you'd like answered? Have you heard or read things on social media that you just don't know if it is true or not? Come and ask the experts.

- ADASS, Public Health England and NHS England are working with the Care Sector in the East Midlands to run sessions for front line social care staff to ask any questions or queries.
- The session will be hosted by staff – Public Health Consultants, Doctors and Nurses all of whom are involved in the vaccination programme.
- They will answer your questions as best they can, there is no such thing as a wrong question.
- You do not need to book on to the session.
- You do not have to tell your manager you are joining.
- We will not keep a record of who has attended.
- We will however use the things you ask us and tell us to produce more information for other staff as if you have a thought or a question it is likely other people may have the same question or query.

## **Frequently asked vaccination questions in LLR**

The Clinical Commissioning Groups in LLR have published a quick guide to the common questions people have asked about the COVID-19 vaccine. Amongst other key messages about the vaccine, it includes confirmation that religious leaders have agreed that the vaccine can be taken by Muslims, Hindus and Sikhs, as well as all other religions.

## **Monthly reporting - ICF2 and Rapid Testing Fund**

Please ensure that your ICF2 February expenditure report is submitted by 15 February. This will summarise all actual eligible expenditure for the period 1 October to 31 January. Care home providers will see that online form has been adapted so that you can report Rapid Testing Fund expenditure at the same time, for the period 2 December to 31 January.
