Social Care Day of Remembrance and Reflection

A <u>Social Care Day of Remembrance and Reflection</u> will be held on 17 March, recognising the recent and ongoing challenges faced by the adult social care sector.

A range of organisations have collaborated to develop the day, and have created <u>Memorial</u> and <u>Thank You</u> walls to give the opportunity to remember people sadly lost during the pandemic. It also offers a time for reflection on the critical role that the adult social care sector plays to keep people safe and supported.

Revocation of VCOD: latest update

As we reported in <u>bulletin 131</u>, regulations making COVID-19 vaccination a condition of deployment (VCOD) in health and social care will be revoked with effect from Tuesday 15 March.

A document has now been produced answering <u>frequently asked questions</u> on the revocation of VCOD which we recommend that you read.

The government is clear that those working in health and social care have a professional responsibility to be vaccinated and boosted against COVID-19, and so your efforts in continuing to promote vaccine confidence in your workforce and emphasise the importance of booster vaccinations is appreciated.

Capacity tracker

Please continue to update the national capacity tracker regularly, and for all of the requested fields – as you know, the data which you submit provides critical information to a range of agencies, enables us to support you better, supplies intelligence for requests for additional support for the sector, and is a condition of receipt of national COVID-19 funding.

Funding may be withdrawn from providers not completing the tracker regularly.

Care homes should, in particular, remember to close outbreaks on the tracker after 14 days.

LLR adult social care winter worker retention package for CQC-registered providers

A significant proportion of providers have not yet submitted a claim for the NHSfunded LLR adult social care worker winter retention package for CQC-registered providers, so thousands of staff could miss out on the package. It is essential that those providers submit a template urgently so that payment can be made quickly.

In order to be paid, templates must be submitted in sufficient time such that payments can be made by 31 March - unfortunately claims made after that date cannot be paid.

Last chance to order free PPE locally for non-COVID-19 or COVID purposes

As outlined in <u>bulletin 127</u>, the government has confirmed that from 1 April 2022 the Local Resilience Forum will no longer be required to provide free PPE to services across Leicester Leicestershire and Rutland.

Free stock is available to providers and we encourage you to take advantage of this offer, which we are not limiting to COVID-19 purposes. All orders must be placed by the end of day on Monday 14 March to allow orders to be processed. This offer will not affect your supply from the national portal.

Currently items in stock available to order include:

- Protective gloves
- Aprons
- Hand sanitiser
- Visors
- Waste sacks
- Non-sterile gowns
- Coveralls
- FFP3 masks

Order now for collection by <u>filling in the online form</u> (green 'order PPE now' button towards the bottom of the web page) indicating the quantities of the equipment you would like to request on a one-off basis. Please ignore the month's supply note.
