Revocation of VCOD regulations: latest update

As we reported in <u>bulletin 132</u>, regulations revoking vaccination as a condition of deployment (VCOD) in health and social care came into force on Tuesday 15 March 2022. The <u>revocation of VCOD frequently asked questions document</u> has been updated, and we recommend reading it.

LLR adult social care winter worker retention package for CQC-registered providers

In <u>bulletin 132</u>, we reported that a significant number of eligible providers had not submitted a claim for the NHS-funded LLR winter retention package for CQC-registered providers, which meant that thousands of staff may have missed out. We are pleased to report that most providers within scope have now submitted their templates to make a claim.

However, for those eligible providers that have not yet submitted a template, there is a third and final opportunity to do so. There will be a final payment run in April for providers that submit a correct template by Thursday 31 March 2022.

There will be no payments if a template is not submitted at all, or if it is submitted after Thursday 31 March 2022, and due to the conditions and timeframes, unfortunately no flexibility can be offered.

Amendment: closing outbreaks on the Capacity Tracker

Implementing the cap on care costs: consultation underway

On 7 September 2021, the Prime Minister announced that, from October 2023, the government will introduce a new £86,000 cap on the amount anyone in England will need to spend on their personal care over their lifetime.

A national consultation is now underway to gather views on the statutory guidance that outlines how a cap on care costs would operate in practice, and to inform how government can assist local authorities in preparing for its implementation.
